Executive Committee Meeting

February 15, 2019 4:15pm EST by conference call

The executive committee met by conference call February 15, 2019, 4:15pm EST. By way of roll call those present were President Steve Ropski, Past Presidents Don Roush, Larry Koehler, Past Vice President Sister Rose Bast, Vice Presidents Felix Velazquez, Julie Ballenger, Fred Brenner, Adam Ryburn, and Tony Schountz, BIOS Editor Lori Kelman and National Secretary/Treasurer Kathy Roush and assistant Iris Daly.

Steve welcomed everyone. He had several items to discuss.

He wanted to increase the number of Bertholf Award applications. The national office sent the application to all chapters in 2017 and received 12 applications for 2016-2017. The national office sent the Bertholf Award application to all chapter in 2018 and received 8 applications for 2017-2018. The national office will continue to send the Bertholf Award application before the district meeting and with the fall mailing. Felix suggested that the application be given to all chapters at monthly meetings and at district meeting. Most districts give an outstanding chapter based on similar criteria for the national Bertholf Award application.

Steve noted that the membership registrations had declined. He will send a letter that is to be emailed to all chapters to try to encourage more students to become members. He also wanted to encourage all chapters to donate to the research grant fund.

Steve wanted an evaluation form sent to all vice presidents and district directors to use when reviewing the research grants. The national office will send an evaluation form to vice presidents and district directors right away and before the research grant process begins. He also wants the policy of 6 grants per chapter and 3 grants per faculty research advisor sent to everyone when the grants application was made available.

Steve mentioned the cost of Asilomar was \$269,000 and the last Puerto Rico convention was \$176,000 and wanted to be sure we stayed on a budget. Tony mentioned that usually the year that there was not national convention usually had positive revenue. Kathy thought the figures mentioned were incorrect for Asilomar and Puerto Rico and wanted to check the figures. She said that the national office would try to keep the cost of the next national convention as low as possible.

Steve requested everyone send Lori memories of Paul Yokley for publishing in BIOS.

Steve said the audit was completed and the tax return completed, which was needed to maintain the nonprofit status of 501(c)(3). He was told by the auditor the membership revenue was down by \$50,000 and the cost of the last national convention caused a deficit of \$58,000.

The first item of business was the 2020 national convention report located at Columbus State University
Columbus, GA chapter Mu Omicron.

Kathy and Julie reported for the National Convention 2020. The Convention will be from Wednesday May 27 – Sunday May 31, 2020. Executive committee will be in a hotel off campus Monday May 25 – May 31, 2020.

Julie asked if University of South Carolina upstate and Webster University had a biology degree and biology minor. After checking the web page of both Universities, they both have BS degrees in biology and biology minors. The constitution was referenced that regular members had to be biology majors. The committee indicated that Chemistry majors could be associates but not regular members even if they had a biology minor and took enough biology courses to qualify for regular membership. The constitution committee was going look at the wording in the constitution for regular membership qualifications.

Fred moved, and Tony seconded to grant the above listed universities a charter of Beta Beta Beta National Biology Honor Society.

The second item for consideration from the national office is an increase in the membership fees. The national office indicated that by using mass email to all chapters for the fall mailing saved a lot in postage cost.

The national office recommended an increase in membership fees starting August 1, 2019 from \$50 to \$55 for regular, graduate, and honorary members, and from \$40 to \$45 for associate members, and the promoted fees remain the same \$10.

Fred moved, and Tony seconded to increase the fees from \$50 to \$55 for regular, graduate and honorary members, and \$40 to \$45 for associate members and promoted fees remain the same \$10 starting August 1, 2019.

Motion Passed.

The third item of business was the Vice Presidents reports.

Lori reported for BIOS a Quarterly Journal. She said she needed reviewers. She also requested any one send her their memories of Paul Yokley for publishing in BIOS. The May 2018 issue was in printing. The September 2018 and December 2018 issues have lots of pictures and will have no polybags. The 2019 first issue is ready. It was asked at last meeting how many submitted papers did BIOS reject. Last year 8 were accepted. So far this year 7 have been submitted.

Fred reported for the Northeast Region. All district conventions were scheduled. NE-1 will be held at Hofstra University, Alpha Lambda, April 27, 2019, NE-2 will be held at Bloomsburg University Rho Chi March 23. NE-3 will be held at University of Pittsburgh-Greensburg, Theta Pi, April 6. NE-4 will be held at Mount St Joseph, Xi Gamma, April 13.

Julie reported Southeastern Regional Convention meets jointly with ASB (Association of Southeastern Biologists). They have met jointly for 60 years. The 2019 conference will be held in Memphis and organized by Dr. Lee Sutton East Carolina University. Julie will work on the inactive chapters. Steve offered to visit district meeting at no cost to TriBeta. Gannon University had funds that could be used for the district meeting visits.

Felix reported for the Caribbean Region. The Regional convention has been scheduled for May 3-5, 2019. The Zeta Alpha chapter will be the host. Felix wanted to work with any inactive chapters. All chapter were very involved with community service projects and many other projects.

Adam reported for the Southcentral Region. The Southcentral regional meeting will be held the 1st week in April. They have a website for the registration for the regional meeting. Adam was looking for a speaker for the awards banquet. Ali Azghani was stepping down from district director position. Debra Hinson will be the new district director for SC-2. It will be announced at the regional meeting.

Kathy asked if a certificate for retiring advisors could be given to the retiring chapter advisors. Everyone agreed it would be good to give them a certificate for service.

Sister Rose reported for the budget committee. The audit was completed, and the tax return completed which was needed to maintain the nonprofit status of 501(c)(3) with no problems.

Don suggested possibly a student advisory board. A discussion is needed to decide which students should serve on the advisory board.

Tony presented recommendations for the TriBeta investments. He thought Raymond James group charged too much. Kathy reported the Raymond James group would reduce their fees.

A committee was formed to make recommendations and determine the investment goals for the society. The committee members will be Tony, Don, Lori, Amy, and Fred.

Ouestions to the committee were as follows

What are the short-term goals of our investments?

What are the long-term goals of our investments?

Have funds ever been taken from the investment account? Kathy responded that no funds have ever been taken from the investment accounts.

Is it wise to keep more than half our assets in cash/cash alternatives that likely do not keep pace with inflation?

How risk averse are we?

What ratio of stocks to bonds do we want?

How much income from membership dues do we get each year? Kathy responded average between \$400,000 and \$500,000.

How much do we spend each year? Kathy responded close to the same as the income. Off years from the national convention could have \$10,000 to \$30,000 on the positive side.

What are the potential tax implications for a 501(c)(3) entity? Kathy responded no tax implications.

Tony moved to Adjourn.
